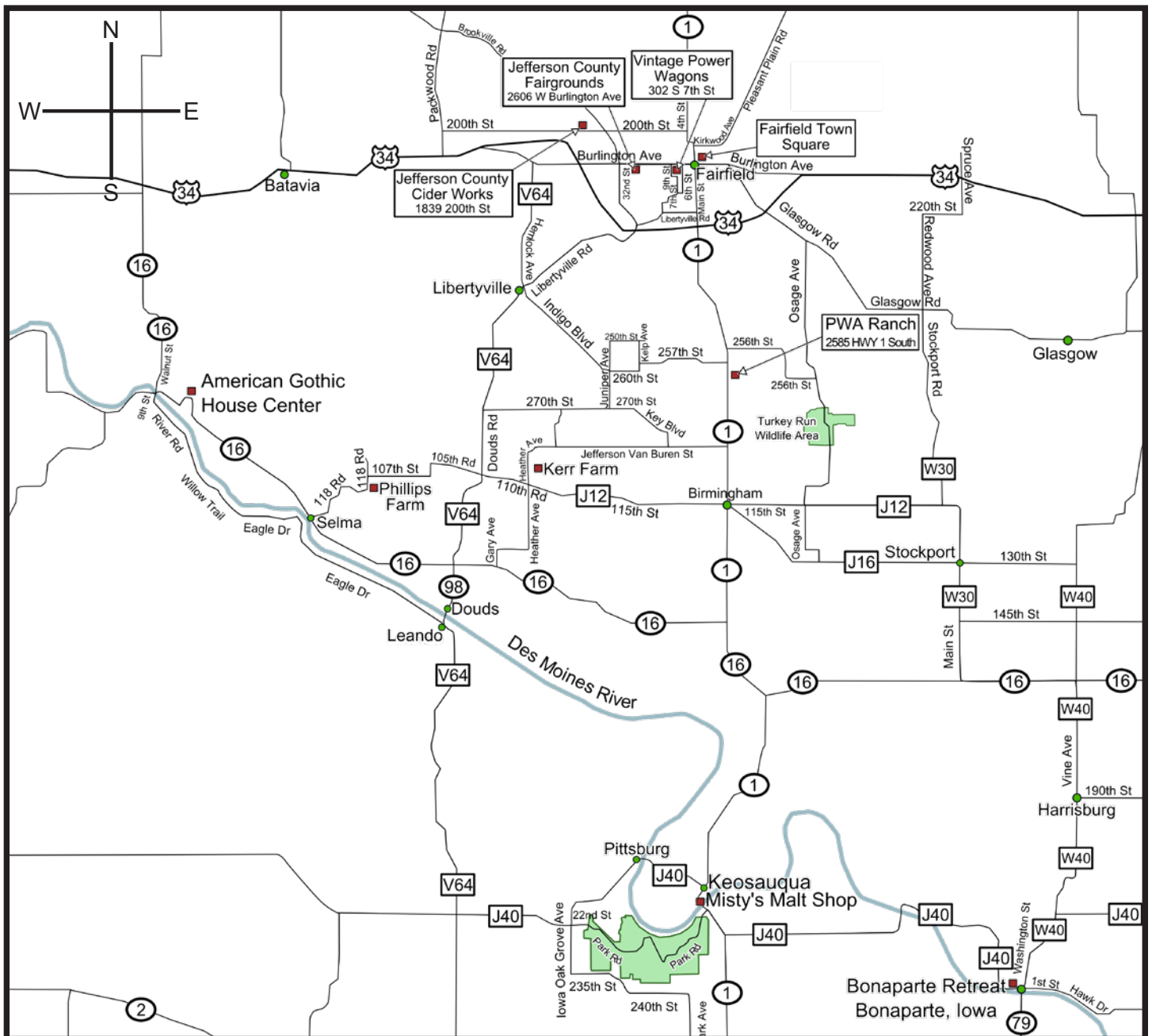

I, the named participant, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby acknowledge that I voluntarily have applied to participate in the VPWR.
